1. Our commitment to privacy

2. What personal information we collect

We may collect and hold the following types of personal information:

- Any other information you voluntarily provide to us

3. How we collect personal information

We collect personal information through:

We only collect information that is necessary for our functions and activities.

4. Why we collect your information

We collect and use your personal information to:

- deliver training and advisory services
- communicate with you about enrolments, schedules, and service delivery
- send updates, newsletters, or promotional materials (with your consent)
- improve our services based on your feedback
- comply with regulatory, legal, or contractual obligations
- administer billing, payments, and customer support

We will not use or disclose your information for any purpose other than the one it was collected for, unless you consent or the law requires it.

5. Disclosure of your information

We may disclose your personal information to:

• our staff and advisors delivering education and advisory services

- our parent organisation, NATA, for administrative and reporting purposes
- third-party service providers (e.g. learning platforms, payment processors, IT support), strictly for operational purposes
- government agencies or regulators where legally required.

All third parties are required to handle your personal information in accordance with this Privacy Policy and applicable privacy laws.

We do **not** disclose personal information to overseas recipients unless it is necessary for service delivery and with your consent.

6. Data security

We take reasonable steps to protect your personal information from misuse, interference, loss, and unauthorised access or disclosure. This includes secure storage (physical and digital), access controls, and data retention policies. When your information is no longer required, we will take reasonable steps to destroy or de-identify it.
